

There is obviously great concern in the village about the number of houses planned, the plans of the individual 13 houses and the proposed insufficient car parking.

There are also the potential additional hazards to the highways which such development would entail.

This has been partly demonstrated this week by the disruption caused by the work on the water pipes around the White Horse. Surely no-one would wish even further chaos caused by a significant building scheme lasting into years?
